UPON THE APPLICATION of Firestone Financial Assets Ltd (**Firestone**) by application notice dated 17 January 2025 (the **Firestone Application**)

AND UPON THE APPLICATION of Adam Henry Stephens and Kevin Ley (the joint administrators of Dolfin Financial (UK) Ltd (the **JSAs**) by application notice dated 28 April 2025 (the **JSAs' Directions Application**) (together with the Firestone Application, **the Applications**)

IT IS ORDERED THAT:

- The JSAs shall serve the sealed JSAs' Directions Application upon Firestone forthwith.

- 5. The costs of the Applications shall be reserved in the respective Applications.
- 6. Liberty to apply.
- 7. This Order shall be served on the JSAs by Firestone.

AND IT IS OF THE COURT'S OWN MOTION ORDERED THAT the JSAs shall if not already done then forthwith upload to the creditor portal the JSAs' Directions Application and this order and such other documents as they consider necessary to enable creditors to consider their position on that Application and if appropriate their attendance at the Hearing
